“For the eleventh consecutive year, we will grant the awards for the best Investor Relations professionals and companies. Companies can qualify when they excel in transparency and disclosure. This is not only about the hard figures, but also about the story behind the figures. The goal is a valuable dialogue with the financial target groups. Dutch companies take a good relationship with their financial stakeholders very seriously, something the NEVIR likes to highlight every year during the Dutch IR Awards”, Uneke Dekkers, board member at NEVIR, said.

The nominations are based on research by WeConvene Extel, combined with additional research among investors and analysts, conducted by communications agency CFF Communications. An independent jury consisting of Corné van Zeijl (ACTIAM), Frederik van Beuningen (Teslin), Holger Weeda (BNP Paribas IP), Joop Witteveen (Kempen), Maarten Verbeek (the IDEA!) and Willem Burgers (Add Value Fund), will decide on the winners in the various categories. Last year’s winners are excluded from participation.

The eleventh edition of the Dutch IR Awards will take place on Thursday January 11, 2018 in Theater Amsterdam. Here, in presence of more than 200 industry professionals, the winners will be announced.
